Mode of Selection:

Selection will be through written test only.

Syllabus:

• The Question Paper will be based on basic subjects of ITI discipline.

Eligibility Criteria to appear for Written Test:

- Pass class in SSC & ITI.
- Only Indian Nationals are eligible.
- Candidates should register their candidature as Apprenticeship on the website https://apprenticeshipindia.gov.in/

Mandatory Documents to be produced for verification at the time of Written Test without which candidates will not be allowed:

- SSLC Marks Statement
- Provisional / Certificate in ITI
- SC/ST/OBC/EWS/PwBD Certificate (if applicable)
- Apprentice registration copy

General Details:

- Candidates who fulfil the above conditions only need to attend written test.
- No TA/DA will be paid to the candidates for attending the selection.
- The duration of Apprenticeship Training is for ONE YEAR only.
- Stipend will be paid as per Government norms (Present rate of Stipend is Rs 8,050/- per month).
- Wearing of mask/ face cover is mandatory for all candidates. Candidates without mask / face cover will not be allowed entry in to the venue.
- Candidates may carry his / her own hand sanitizer (small size) in bottle.
- Candidates should follow COVID norms such as social distancing, personal hygiene inside the examination hall / room as well as in the selection premises.
- Candidates should not be in possession of or using any mobile (even in switch off mode)

Note: Candidates will not be permitted for selection if they do not produce a copy of Apprentice Portal Registration. Canvassing in any form will result in disqualification.
